

Attachment Disorders Versus More Common Problems in Looked After and Adopted Children: Comparing Community and Expert Assessments

Information: Background: Attachment disorders in adopted and fostered children may be overdiagnosed and could obscure more common disorders. Methods: A case note review of 100 referrals to a specialist adoption and fostering service compared community referrals with the specialist assessments of attachment disorders.

Results: Attachment disorders were identified four times more often in community referrals versus the specialist service, but this only partly explained the significant under-identification of more common disorders in the community, especially for neurodevelopmental factors and conduct disorder by up to 10-fold. Conclusions: The relevant practice parameters are discussed and implications for service models for adopted and fostered children reviewed.

Multicultural Families: Deracializing Transracial Adoption

Information: In 2010, the Coalition government announced its plans for adoption reform which included 'removing barriers' to transracial adoption. The government has blamed social workers' looking for 'perfect ethnic matches' for denying black and minority ethnic children placements with 'loving and stable families'. The paper draws upon qualitative research with professionals and parents, which shows that the government has failed to take into account the complex ways in which race and ethnicity matter within adoption. Their wish to deracialize transracial adoption fits with wider concerns about race mixing, families and national belonging in multicultural Britain. While they attempt to minimize the importance of race and ethnicity, they continue to place race at the heart of these debates.

Information: In this study, the parenting stress and parenting behavior of 39 foster mothers of recently placed foster children with externalizing problems were studied. By using standardized measures with normative data, foster mothers' scores on different parenting stress and parenting behavior subscales were compared to published norms.... The prevalence of specific dysfunctional parenting behaviors (e.g., less involvement in positive parenting) was small to moderate, but nearly half of the foster mothers could be classified as making dysfunctional adaptations to their parenting environment....The implications of these results for pre-service training and on-going support for foster parents are discussed.

Information: Understanding the causal impacts of taking at-risk youth into government care is part of the evidence base for policy. Two sources of exogenous variation affecting alternative subsets of the at-risk population provide causal impacts interpreted as local average treatment effects. Placing 16- to 18-year-old males into care decreases or delays high school graduation, increases income assistance receipt, and has alternative effects on criminal convictions depending upon the instrument employed. This suggests that asking whether more or fewer children should be taken into care is insufficient; it also matters which, and how, children are taken into care.

American Indian and Alaska Native communities face unique challenges when participating in program evaluation. Historically, Tribes have experienced intrusive research and judgmental evaluations that have caused many of them great harm. Many evaluators do not understand the fear that persists due to this history, and some fail to respect Tribal cultural traditions, worldviews, and values. CB formed a Tribal Evaluation Workgroup to develop a product that might improve evaluation with Tribal communities. Together, workgroup members created a shared vision for the future of Tribal child welfare evaluation and a guide for developing culturally and scientifically rigorous evaluation. This

publication will be accompanied by two brief videos that introduce concepts described in the Roadmap document. The videos are part of a new Child Welfare Evaluation Virtual Summit Series that will feature presentations on key evaluation topics. The training include first-hand accounts of Tribal youth experiences receiving CWS services. Participants engage in collaborative brainstorming to support goals and objectives. The training allows organizations to focus on specific challenges and identify solutions.

Gathering

The Gathering provides an overview of Native American culture, history, and distrust of government systems and services. The training reviews the unique issues that affect adolescent development of Tribal youth. Participants engage in collaborative brainstorming. The Gathering provides first hand accounts of Tribal youth who have experienced receiving CWS services and basic communication techniques that support more trusting relations with Tribal youth and families. The training allows organizations to focus on specific challenges and identify solutions.

Collaborative

The Collaborative is an adapted half-day training designed to introduce Tribal and non-tribal child welfare workers to the challenges of serving Tribal foster youth. It covers a brief historical overview and concludes with recommendations that support increased communication and collaboration among providers that strive to achieve positive outcomes for Tribal youth.

Training-for-Trainers

Training for Trainers focus on skill building to lead cross-cultural discussions that result in positive outcomes. The training also helps participants learn how to conduct Tribal STAR training in their area. Topics covered in the training include cross-cultural communication, cultivating and maintaining trust-based relationships, and

understanding how history affects today's relationships between CWS and Tribal programs.
