**COURSE DESCRIPTION:** The County of San Diego Behavioral Health Services Children, Youth and Families (BHS-CYF) provides services to children who are insured by Medical as well as unfunded youth up to age 21 who have serious/severe behavioral health difficulties. This course will help training participants to understand and diagnose complex conditions in the Children's System of Care and develop treatment recommendations that follow the diagnoses. This training will provide tools to facilitate a rapid and reasonable identification of issues that a particular child or family may bring and methods for arriving at a diagnosis or set of diagnoses that represents the complexity of the needs of the child or family. Specific treatment concepts will also be presented. \*This training will be offered multiple times over the next 4 months. Look for upcoming flyers.
