## **Lead Presenter**

Bonnie Olsen, Ph.D. is a clinical psychologist with extensive experience as a Geropsychologist, working in academic medicine for over 20 years. As the Vice Chair of Academic Affairs in the Department of Family Medicine at the Keck School of Medicine at USC. Dr. Olsen is involved in a number of research and program grants that focus on elder abuse education and prevention. She is particularly interested in elder mistreatment and self-neglect as it occurs in the context of dementia and understanding decisional capacity. Dr. Olsen has worked directly with Adult Protective Services providing capacity assessments for their clients and has guest lectured throughout the country on the topic. She is a passionate advocate and expert for elder justice.
