This two-day, application-focused training provides participants with an in-depth look at the foundations of the Criteria, including clinically driven services, biopsychosocial assessment, the six dimensions, continued stay and transfer/discharge criteria. Incorporating the use of The ASAM Criteria (3rd edition), participants have opportunities for skill practice at every stage of the treatment process: assessment, engagement, treatment planning, continuing care and transfer or discharge. As part of the training, all participants receive an in-depth Training Journal to guide the training experience and as a resource for continuing skill application.

**AUDIENCE:** SUD Counselors, peer specialist and family support partners, case managers, and other direct service providers working with adults and older adults.
