### Training Outline

This training will provide trainees with tools to identify and successfully be able to apply knowledge of how withdrawal management treatment for program participants within an outpatient setting. Information will be provided on how to residentially navigate the coordination of care process in San Diego DMC-ODS in a timely and efficient manner as well as information on the ongoing transition between mental health and substance use services with the goal to integrate the two fields of service and improve the experience for individuals under the single umbrella of Behavioral Health.
