Course Description

People of color who identify as transgender or gender nonconforming (GNC) experience unique struggles due to the intersection of gendered bias and structural and interpersonal racism. This marginalized population often has increased psychosocial, medical, and mental health concerns, and will present complex scenarios for providers to navigate. In order to provide responsive care, service providers must recognize the ways in which the intersectionality of gender identity and culture affects this population.

During this event, the 2015 National Transgender Discrimination Survey will be used to provide data to demonstrate the increased levels of discrimination for transgender and gender nonconforming individuals of color. We will discuss the importance of using a gender-affirming, culturally responsive lens, as well as the importance of using a wraparound approach when working with youth and their families. Participants will respond to clinical vignettes and case scenarios, as well as participate in group discussion and brainstorming to help with case conceptualization, case planning, and strategies to provide gender-affirming and culturally responsive care on an individual and organizational level.

- Identify strategies to support gender-affirming, culturally responsive strategies to support transgender or GNC persons of color
- Practice interventions to implement gender-affirming, culturally responsive strategies to support transgender or GNC persons of color
- Discuss interventions to provide gender-affirming, culturally responsive service when the gender identity of a youth being served is not accepted by the youth's family or cultural community
