This training provides an overview of the Prospective Risk Analysis (PRA) tool which replaces the current High Risk Assessment. The intent of the PRA is not to change the way we assess for risk, but rather to build on our existing diagnostic and therapeutic skills. Using Dr. Shawn Shea's Chronological Assessment of Suicide Events (CASE) Approach combined with the PRA will allow clinicians to develop a consistent way of assessing for risk.

- Describe how the Prospective Risk Analysis enhances the process of assessing for self-injury, suicide and violence.
- Apply the interviewing skills and techniques to develop a clinical formulation of risk.
- Recognize and be able to utilize the following seven interviewing techniques for uncovering sensitive and taboo material: normalization, shame attenuation, the behavioral incident, gentle assumption, denial of the specific, the catch-all question, and symptom amplification.
- Be able to utilize flexible strategies for weaving the above seven validity techniques into effective methods of uncovering sensitive material related to suicide such as antisocial behavior, substance use, and violent ideation, while maintaining a powerful engagement.
