Lori Delagrammatikas, MSW, Executive Director, National Adult Protective Services Association (NAPSA) – Prior to NAPSA, Lori worked as the governor-appointed Adult Protective Services Liaison to the counties from the California Department of Social Services. In this role, she worked collaboratively with county, state and federal agencies to promote consistent and compliant APS statewide practice, and strengthen and expand services to older adults and adults with disabilities. Before coming to the state, Lori worked for eight years as the program manager of the M.A.S.T.E.R. program at the Academy for Professional Excellence, San Diego State University where she spearheaded the development of the NAPSA's 23 core competency training modules for Adult Protective Services. She has received NAPSA Collaboration Award and the NAPSA 2016 Distinguished Service Award.
