

California APS Consistency in Determining Findings Multi-Module Virtual Skill Building Training



Description

In this engaging advanced virtual training, participants receive the opportunity to build upon the foundations learned in the prerequisite eLearning and practice determining findings to create consistency throughout the state. It is packed with practice scenarios to help participants work through the **California APS Standards for Consistency in Determining Findings Matrix** and better understand the findings standards set forth in the **Guiding Principles for Consistency in Determining Findings**. Participants will also have an opportunity to write findings in rational narrative, providing a framework for presenting logical justification for findings.

This course has been developed as a blended learning composed of an eLearning and two virtual modules, including individual practice. Participants will first complete the eLearning to gain the foundation needed for the virtual skill-building modules.

Learning Objectives

By the end of this training, participants will be able to:

- Determine potential abuse by identifying the abuse indicators, using the *CA APS Standards for Consistency in Determining Findings Matrix*.
- Critique if evidence meets the abuse type's legal components (Essential Defining Elements, interpreted from the Welfare & Institutions Code) during scenario based skill practice.
- Construct a findings rational narrative that includes the components required for it to be descriptive and complete.

Course Requirements
