

The Cornell-Penn Interview for Decisional Abilities (IDA) IDA Practitioner Course Participation Agreement

This form **MUST** be completed before learner can enroll in the IDA Practitioner course.

Certification as an Interview for Decisional Abilities (IDA) Practitioner represents a high standard of professional practice.

An IDA Practitioner certification is granted at the conclusion of IDA Practitioner online course when the participant successfully completes the course and evaluation requirements. The certification allows the practitioner to use the IDA tool in the field.

The IDA Practitioner course is designed to provide Adult Protective Services workers with a deep understanding of the Interview for Decisional Abilities tool and the ability to practice the IDA accurately and consistently in the field. This process affirms our commitment to ensure that IDA is implemented by Adult Protective Services workers to capture an individual's general understanding and personal appreciation of risk as well as their ability to make reasoned decisions about service options.



Requirements for IDA Practitioner certification include completion of the following:

- Read and complete assignments in IDA modules 1-6
- Participation: Live Role Play Workshop
- Live Workshop Completion Survey
- Field Assignment: Complete and submit a Cornell-Penn IDA
- Check Your Understanding: Final Exam
- Program Completion Survey

Participants agree to practice in accordance with IDA principles taught in the course and follow these guidelines while using the IDA in the field. **Privileges associated with IDA Practitioner certification include the ability to practice the IDA in the field** and access to the online IDA course for an additional year.

Terms of Use
