# **APS Supervisor Core: Supervising APS Investigations Involving Transnational Financial Fraud**



This training was developed to provide APS supervisors with a foundation for effective supervision of APS investigations involving transnational financial fraud crimes. Learners will discuss strategies for helping investigators address common roadblocks, explore ways to help investigators practice financial fraud prevention with APS clients, and identify action steps to share with investigators assisting repeat victims.
